1. Call to order. 00:00:09

6. Review and approve the Final PUD Plan of The Cornerstone 6<sup>th</sup> Addition. 00:02:44

Vice-Chairman Lindebak recused himself from any discussion due to business relations.

Les Mangus explained that this Final PUD is in compliance with the Preliminary PUD document. Due to a change in the market this is a smaller phase allowing the developers to downsize the size of plats filed, lowering the number of lots on the market. MKEC has been in contact with the utilities concerning additional easements as noted on the latest revision to the Final PUD.

Jason Gish, MKEC, was present to represent the application.

Mr. Gish thanked the Planning Commission for continuing this meeting. This phase contains 33 lots and design plans are currently in process.

Chairman Heath asked if the street lights requested by Westar were included in the plat.

Mr. Gish replied that they were included. Also included are the 20 foot drainage easements as requested by the Subdivision Committee providing proper drainage across the lots.

*A motion was made by William Schnauber, seconded by Lee Butler to approve the Final PUD Plan for The Cornerstone 6<sup>th</sup> Addition as presented. Motion carried 6/0.*
