**ORDINANCE NO. 1826**

**AN ORDINANCE ANNEXING LAND INTO THE CITY OF ANDOVER,  
KANSAS.**

WHEREAS, the land described below adjoins the existing boundaries of the City of Andover, Kansas (the "City") and a written petition for annexation of said land has been signed by each and all owners thereof, and have been filed with the City pursuant to K.S.A. 12-520(a)(7), as amended, and therefore, pursuant to K.S.A. 12-520a(f), no resolution, notice or public hearing are required; and

WHEREAS, the Governing Body of the City finds it advisable to annex such land.

**NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE  
CITY OF ANDOVER, BUTLER COUNTY, STATE OF KANSAS:**

Section 1. That the following described land is hereby annexed and made a part of the City:

Commencing at the Southeast Corner of the Southwest Quarter of Section 30, Township 27 South, Range 3 East of the Sixth Principal Meridian, Butler County, Kansas, thence N 00°37'22" W, a distance of 50.00 feet to the Point of Beginning at Southeast Corner of Meadowbrook 2<sup>nd</sup> Subdivision; thence N 00°37'22" W, a distance of 263.40 feet; thence N 89°03'14" E, a distance of 330.50 feet; thence S 00°37'22" E, a distance of 263.40 feet; thence S 89°03'14" W, a distance of 330.50 feet to the point of beginning.

Section 2. The City Clerk is hereby authorized to provide any and all notices necessary to comply with K.S.A. 66-1,176 with respect to this annexation.

Section 3. Pursuant to K.S.A. 12-522, upon passage and publication of this annexation ordinance (the "Ordinance"), the City Clerk shall file a certified copy of such Ordinance with the County Clerk, the Register of Deeds, and the County Election Commissioner, if any, of Butler County.

Section 3. This Ordinance shall take effect and be in full force from and after its adoption by the Governing Body of the City, approval by the Mayor and publication once in the official newspaper of the City.
