The action tonight is to consider a recommendation to the City Council to annex the property. The property is adjacent to Andover Rd. Access to Andover Rd. could be granted. Public water and sewer are available is needed. Staff supports the annexation as requested. The applicant has requested this case be withdrawn.

Z-2010-02 & SU-2010-03- A continuance of a proposed change of zoning district classification from the Butler County Rural Residential District (RR) to the City of Andover B-1 Office Business District at 16051 SW 123rd Terrace and a special use request to establish a mini-storage facility at 16051 SW 123rd Terrace.

From Les Mangus' Memo: The proposed change of zoning district

classification from the Butler County Rural Residential District (RR) to the City of Andover B-1 Office Business District at 16051 SW 123rd Terrace and a special use request to establish a mini-storage facility at 6051 SW 123rd Terrace is the desire of the applicant to build a storage facility adjacent to his residence. No development plan has been submitted but the area around the subject property has some commercial uses. Staff supports the application contingent on a suitable site plan and screening. The applicant has requested this case be withdrawn.
